

PRIVACY POLICY

STALIUS MANAGEMENT LTD, a legal entity under the laws of Cyprus, organization number HE 462691, registered office: Koumandarias, 6, 3036, Limassol, Cyprus operates <https://www.adsight.app> website (the Site). This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use the Site and the choices you have associated with that data. STALIUS MANAGEMENT LTD uses your data to provide and improve our Services. By using the Site, you agree to the collection and use of information in accordance with this policy.

Definitions “Personal Data” means data about an individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

“Usage Data” means data collected automatically either generated by the use of the Site or from STALIUS MANAGEMENT LTD Services (for example, the duration of a page visit).

“Cookies” means small pieces of data stored on your device (computer or mobile device).

“Data Controller” means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed. For the purpose of this Privacy Policy, STALIUS MANAGEMENT LTD is a Data Controller of your Personal Data.

“Data Processors” means any natural or legal person who processes the data on behalf of the Data Controller. STALIUS MANAGEMENT LTD may use the services of various Data Processors in order to process your data more effectively.

“Data Subject” is any individual who is using our Services or visiting the Site and is the subject of Personal Data.
Information Collection And Use We collect several different types of information for various purposes to provide and improve our Services to you.

Types of Data Collected

While using the Site, STALIUS MANAGEMENT LTD may ask you to provide us with certain personally identifiable information that can be used to contact or identify you and to get benefits from personal access to our Services. Personally identifiable information may include, but is not limited to:

- Email;
- Account details;

STALIUS MANAGEMENT LTD may use your Personal Data to contact you with newsletters, marketing or promotional materials, offers and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by following the instructions provided in any email we send or by contacting us.

Usage Data

STALIUS MANAGEMENT LTD may also collect information that your browser sends whenever you visit the Site or when you access our Services. This Usage Data may include information such as your computer's IP address, browser type, browser version, the pages of the Site that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data. When you access the Site by or through a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

Tracking Cookies Data

STALIUS MANAGEMENT LTD uses cookies and similar tracking technologies to track the activity on the Site and hold certain information. Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from the Site and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of the Website.

Use of Data

STALIUS MANAGEMENT LTD uses the collected data for various purposes:

- To provide and maintain our Services;
- To notify you about changes to our Services;

Legal Basis for Processing

- If you are from the European Economic Area (EEA):
- You are intended to become our customer;
- You have given us permission to do so;
- To comply with the applicable laws.

Retention of Data

STALIUS MANAGEMENT LTD will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. STALIUS MANAGEMENT LTD will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. STALIUS MANAGEMENT LTD will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

Transfer Of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction. STALIUS MANAGEMENT LTD will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

Disclosure Of Data

If STALIUS MANAGEMENT LTD is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy. Disclosure for Law Enforcement Under certain circumstances, STALIUS MANAGEMENT LTD may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).
